AMENDMENTS:-

However, it is noted that both individuals have not been able to actively participate in the affairs of the Trust or contribute sufficient time to its activities, which has necessitated this action in the best interest of the Trust's functioning.

All necessary legal formalities and procedural requirements to give effect to this resolution shall be duly undertaken.

NOW THIS INDENTURE WITNESSES as follows:-

1. That in order to effectuate his aforesaid desire, the settler has set apart and handed over the Trustees, a sum of Rs. 50,000/- (hereinafter called the "Trust Fund" which expression shall include cash and any other property or investments of any kind whatsoever into which the same or any part thereof might be converted invested or varied from time to time or which may be acquired, by the Trustees or may come to their hands by virtue of these presents or by operation of law otherwise howsoever in relation to these presents) and or the Trustees shall hold and stand possessed of the same upon the Trust objects of the powers, provisions, agreements and declaration hereinafter contained.
2. Name: The name of the trust shall be "RAM JANKI EDUCATIONAL AND HELTH TRUST" The Trustees may change it if they mutually so decided in future.

4. **Area of Operation:** The operational area of the trust shall be whole Bihar and it may be extended to whole India or can be reduced as the Trustees may decide.
5. **Funds of the Trust:** The assets together with all further donations and contributions, in any shape or form made to the said Trust from time to time and the rents, profits and income thereof and the stocks, fund and properties representing the same shall be held by the Trustees upon Trust for the objects and purposes and subject to powers and provisions here inafter set out.
6. **Objects of the Trust:** The objects of the Trust are to :-
 - 6.1 Establish, run, develop and management of hospitals, medical, school and colleges, pharmacy and dental college, nursing institutions, dispensary, maternity home, technical or non-technical educational institutes, management college, child or women welfare centers, B. Education & Training, I.T.I., industrial and or such similar institution in India for the benefit and use of the general public.
 - 6.2 Establish, run, develop and management assist and support school, colleges, libraries, residing rooms, laboratories research and other institutions of the like nature in India for the development and advancement of education and diffusion of knowledge amongst the public in general.
 - 6.3 Establish, run, develop and management studentships, scholarships and render other kind to aid to students include supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.
 - 6.4 Promote, Establish, run or manage institutions for the promotion of science and technology, management, literature, music, drama and fine arts in India for the benefit of the public in general.
 - 6.5 Establish, run, maintain or manage for the establishment and or maintenance of parks, gardens, gymnasiums, sports clubs, dharamshalas and rest houses for use by public in general.
 - 6.6 Establish, run, maintain or manage homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
 - 6.7 Establish, run or manage institutions or centers for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
 - 6.8 Grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilences etc. and to give assistance to institutions, establishments or persons engaged in such relief work.

- 6.9 Organize or promote programmes of Training in Social Work as and when required and also to study and analyze govt. plan, policies and social problems requiring urgent intervention through surveys, research and evaluation in such manner as may be considered necessary.
- 6.10 Promote or join the promoting or conduct, undertake or participate in national and international exhibitions, museums seminars, conferences and conventions.
- 6.11 Establish, run, maintain or manage institution, programmes or centers for :-
1. Promotion and expansion of Handicrafts.
 2. Welfare and protection of consumer's right.
 3. Self-Help Group of men and women for their development and socio-economic change.
 4. Check of atrocities against women and children.
 5. Eradication of child labour problem and rehabilitation of bonded labour.
- 6.12 Promote or organize or implement activities for the promotion of horticulture, social forestry and forest expansion and to promote the activities to save the environments from pollution.
- 6.13 Make efforts for information dissemination, R & D to expedite the non-conventional source of energy.
- 6.14 Promote and execute activities like sanitation, water supply, and rural health, construction of roads, and other for rural reconstruction whenever necessary.
- 6.15 Promote, produce, sale and advertise khadi products and village industries as approved by khadi & village industries commission.
- 6.16 Undertake all act, deeds and things connected with, incidental to and germane to the aforesaid objects.
7. Board of Trustees: The Trust shall be vested in a
- 7.1 Board of Trustees (hereinafter called the Board) which shall consist of not less than three and not more than nine trustees. The first Trustees constituting the Board are:

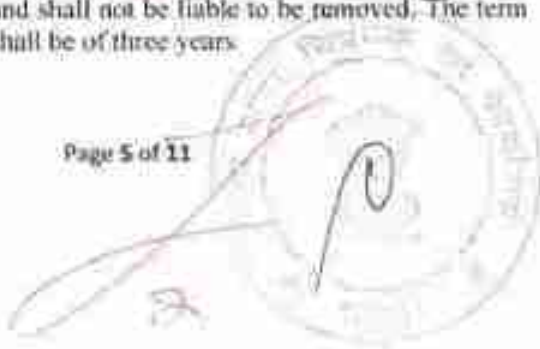

The Board of Trustees shall have one Chairman. The first Chairman of the Board will be Mr. Sanjay Kumar Mishra and he will continue as the chairman of the Board during his pleasure and shall not be liable to be removed. The term of all other trustees shall be of three years.

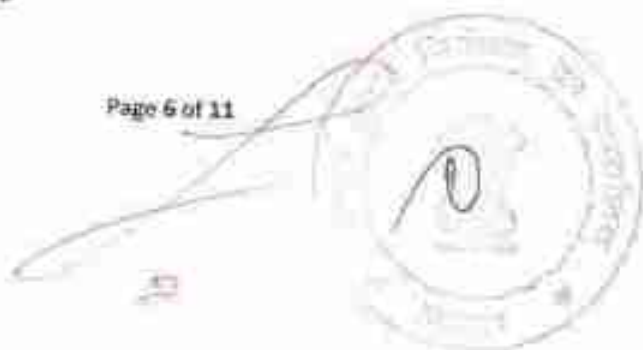


- 7.2 The first trustees constituting the Board shall have the power to increase the strength of the Board by appointing there to one or more persons on the recommendation of Chairman, whether on the same occasion or on different occasions, as trustee or trustees, but the total number of persons constituting the Board shall at no time exceed nine.
- 7.3 In the event of vacancy in the office of Chairman, the Board shall select a Chairman from amongst themselves.
- 7.4 If any of the trustees shall die, or desire to retire, refuse or become incapacitated to act as a trustee or take the benefit of insolvency law, then and in every such case, there shall be a vacancy in the Board.
- 7.5 A trustee may be removed from office for misconduct or for obstruction of the functioning of the trust by a resolution adopted by two-third majority of the members of the Board present and voting at a meeting specially called for the purpose. The trustee affected shall be given reasonable opportunity to show cause against the proposed action.
- 7.6 Vacancies in the Board may be filled by the remaining trustees at a meeting called for the purpose, casual vacancies in the Board may be filled in the manner aforesaid for the unexpired part of the term of the trustee causing the vacancy. A retiring trustee shall be eligible for re-election.
- 7.7 The quorum for a meeting of the Board shall be 1/3rd of the then existing members.
- 7.8 Vacancies in the Board shall not invalidate the any of the proceedings of the Board.
- 7.9 The Board may meet as often as necessary and, in any event, not less than twice in a calendar year.
- 7.10 Decisions at the meeting of the Board shall be taken by a vote of the majority of the trustees present. In the case of equality of votes, the Chairman of the Board shall have a second or casting vote.

8. Powers & Functions of the Board of Trustees

For the furtherance of the objects of the Trust, the Board of Trustees shall have the following powers and functions:-

- 8.1 To accept any donation, contribution, grant, loan or subscription in cash or kind, from any person(s), body of persons or trust, with or without conditions.
- 8.2 To apply the whole or any part of the income of the trust, or the trust fund or accumulations there to, to anyone or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- 8.3 To convert and deal with the trust property and or any investments for the time being.



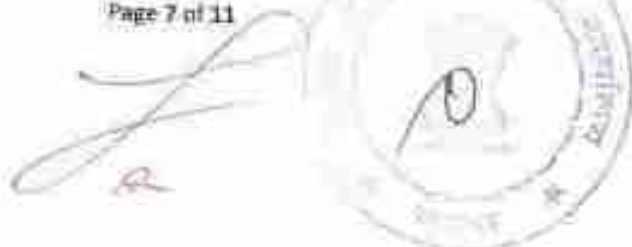

- 8.4 To invest the trust fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any company, bank, firm or any other person, and to alter, vary or transmute such investment, from time at the discretion of the Trustees.
- 8.5 To borrow or raise or secure payments of moneys and also to lend money either with or without security.
- 8.6 To sell, dispose of, alienate or otherwise deal with any property comprising the Trust Fund.
- 8.7 To let out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.
- 8.8 To adjust, settle, compromise, compound, refer to arbitration, all actions, suits, claims, demands and proceedings regarding the Trust Fund.
- 8.9 To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time to remove such attorneys or agents and to appoint other in his or their place.
- 8.10 To appoint or make provision for the appointment of any person for the purpose of the administrations of the Trust in such manner and subject to such rules and regulations as the trustees may prescribe an also to appoint or provide for the appointment of separate Trustees to hold any fund or investment subject to the provisions of this Deed in such manner and subject to such rules and regulations as the Trustees may from time to time think fit.
- 8.11 To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the managements of the affairs there of and/or running any institution of furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- 8.12 To start, abolish, discontinue and restart any charity or charitable institutions for the benefit of the general public and to impose any conditions to any subscription or donation made by them.
- 8.13 To set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.
- 8.14 To settle all accounts and compromise compound, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned the rebuy.
- 8.15 To apply to the Govt., public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant or money and of aid, donations, gifts, subscriptions and

other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Govt. departments, public and other work and matters within the objects of the Trust and to conform to any proper condition upon which such grants and other payments may be made.

- 8.16 To establish, regulate or ~~discontinue~~ branches, centers or project offices within India or appointing representatives or agents or Advisory Committees.
- 8.17 To subscribe to become a member of or otherwise cooperate with any other Trust or its branch ~~whether incorporated or not~~ whose objects are either wholly or in part similar to those of the Trust of which would promote the interest of the Trust.
- 8.18 The Trustees shall, from and out of the income realized from the properties, assets and funds of Trust and from other such endowments and from the Govt. grants and from any other sources which they may get, expend such sum or sums of money as they may deem proper towards the maintenance of the properties of the Trust, pay all rates and taxes, pay such sums towards the repayment of any borrowing by the Trustees and meet all expenses which the Trustees may in their discretion think necessary for the proper and efficient management of the Trust and in particular pay the salaries and allowances of all staff and servants, purchase of books, equipment's and furniture's, pay management contribution for the Provident fund of the staff, Gratuity, Pension etc., awards prizes or scholarships to studentships to students and incur any other item of expenditure, relating to the institution if any, under the management of the Trust not here in before specially mentioned, it being understood that the above enumeration gives no priority to any particular item of expense, no or is the same exhaustive.
- 8.19 The Board of Trustees have management of the affairs of the Trust and the overall supervision and superintendence of the Trust and all institutions run by the Trust and all matters incidental there to.

9. Accounts and Audit:

- 9.1 The account or accounts of the Trust shall be opened by the name of the Trust and/or branches, project offices, centers of institutions run or conducted by the Trust with a Nationalized or Scheduled Bank or other Bank approved or permitted by Reserve Bank of India or in Post office and it shall be operated by one or more of the Trustees or such person authorized by Board of Trustees time to time.
- 9.2 The accounts of the Trust shall be audited every year by Chartered Accountant or a firm of Chartered Accountants, that will be appointed by the Board of Trustees.
- 9.3 The audited accounts of the Trust shall be adopted at a meeting of the Board of Trustees called for the purpose and remuneration of Chartered Accountant or Firm of Chartered Accountants shall be fixed by the Board of Trustees.

10. Power to Amalgamate :

The Board of Trustees may allow and permit any other Trust Institution or Charity, in any local area of areas whose objects are either wholly or in part similar to those of these presents to the intent and effect that such other Trust, Institution or Charity shall be deemed to be a part and parcel of the Trust created by these Presents, provided that no conditions are accepted which involve a change in the name of this Trust or inconsistent with or repugnant to the objects of this Trust.

11. Indemnity:

11.1 The Trustees shall be chargeable only for such money, stocks, funds, deposits and securities as they shall actually receive, not with standing their signing any receipt for the sake of conformity and shall be answerable or accountable only for their own deliberate or wilful acts of omission or commission.

11.2 No Trustees shall be liable for any breach of Trust committed by the Co-trustee except in respect of his own act and in respect of any property in his custody.

12. Power to Reimburse:

The Trustees of these presents are entitled to be reimbursed an also to pay and discharge out of the Trust Fund, all expenses incurred by them or on their behalf in or about the execution of the Trust and the powers of these Presents.

13. Allowances to Trustees & office-bearers

If at any time any Trustee acts as a whole time office-bearer of the Trust or renders any special service, the Board of Trustees may in its discretion pay such remuneration or allowances to such Trustee as it may think proper.

14. Accounting year of the Trust

The accounting year of the Trust shall be the financial year ending on 31st March every year.

15. Regulating and bye-laws

15.1 The Board of Trustees shall be entitled to frame, modify, amend, alter or repeal rules and bye-laws for the purpose of administering the Trust.

15.2 This Trust, Trust Fund and the provision relating to the appointment of the first Chairman of the Board are irrevocable. Subject as aforesaid, the terms of this Deed may be amended, altered or modified by majority of 2/3rd members of the Board present and voting in a meeting called for the purpose. Provided, however, that no amendment contrary to the objects of the Trust here in before set forth shall be valid and effective.

16. Succession of The Settlor

Upon the demise of the Settlor, any one eligible member from the family of the Settlor may be nominated to assume the role and responsibilities of the Settlor, subject to the prior written consent and approval of the majority of the continuing Trustees. Such nomination shall be duly recorded in the minutes of the Trust and the newly appointed Settlor shall enjoy all rights and obligations as originally vested in the Settlor under this Deed.

17. Jurisdiction of Courts :

The competent Court in Patna, shall have exclusive jurisdiction to decide any question regarding the interpretation and construction of this Deed or administration of the Trust and the related matters. In the event of such courts having concurrent jurisdiction with any other court or courts in respect of any claim or dispute against or by the Trust or Trustees or any other matter connected therewith, the competent courts in Patna, shall have jurisdiction to entertain, try and determine such claim or dispute in exclusion of such other court or courts.

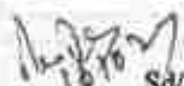
